Important Changes

Beginning on January 1, 2004, MLS will no longer be tracking potential Dislocated Worker Layoff Events. The potential Dislocated Worker Layoff Event consists of a company that has at least 20 initial UI claims filed against the company but has less than 50 initial UI claims filed against it. The number of initial UI claims filed against a company must be equal to or greater than 75 percent of the Establishment Employment in order to be considered a potential Dislocated Worker Layoff Event. The result of eliminating the potential Dislocated Worker Layoff Event would be a reduction in the potential of smaller level of layoffs and, consequently a reduction of the total number of confirmed layoffs due to these actions.

Beginning on January 1, 2004, MLS will no longer be tracking layoffs for companies that are involved in the agriculture, forestry, fishing and hunting sectors. MLS will also no longer track layoffs for companies in the government sector as well. The result of this action would be a reduction in the total number of confirmed layoffs due to these actions.
